Information for Persons Charged with Intoxicated Driving

Anti-Intoxicated Driving Programme



The “Anti-Intoxicated Driving Programme” is an alternative to a prison sentence.

It is a probationary sentence that may be given for intoxicated driving.

The goal is to prevent a repeat of the intoxicated driving, in order to create a safer traffic environment and reduce the number of accidents.



This sentence is for persons who:

- would otherwise have been sentenced to prison for intoxicated driving and
- have a problem with alcohol or narcotics, or
- have only a minor problem with alcohol or narcotics, but a problem with driving when intoxicated.

Instead of prison, your sentence will be carried out at your local probation office. The sentence normally lasts for 10 months, and involves:

- Individual meetings about every two weeks. The topic of conversation is adapted to your needs.
- Group meetings (20-30 hours). These take place over two to three months.
- Assessment of whether you need treatment and therefore are entitled to alcohol or substance abuse treatment from specialised healthcare services.

The goal is that you should

- understand what makes it more likely that you will drive while intoxicated
- be more motivated to make other choices than intoxicated driving
- find ways to help yourself to avoid driving while intoxicated again

If you break the rules or commit another crime during probation, the probation sentence may be replaced by a prison sentence.

Does the Anti-Intoxicated Driving Programme sound like a good idea for you?

Contact your lawyer, the police or the prosecuting officer and ask for a personal examination. This will provide information to assess whether you are suitable for the Anti-Intoxicated Driving Programme.

The personal examination will be carried out at the probation office.
